Your privacy is very important to us. This notice (this "Privacy Notice") is provided by Capstone Investment Advisors, LLC on behalf of itself and its affiliates (collectively, "Capstone", "we" or "us"), and sets forth the policies of Capstone for the collection, use, storage, sharing, disclosure, protection and otherwise processing (collectively, "processing") of personal information. This Privacy Notice is being provided in accordance with the requirements of data privacy laws, including the EU General Data Protection Regulation 2016/679 (including the UK's retained version of Regulation EU 2016/679) ("GDPR"), the US Gramm-Leach-Bliley Act of 1999, as amended, the Data Protection Act (as amended) of the Cayman Islands ("DPA"), the California Consumer Privacy Act of 2018 ("CCPA"), or any other applicable law relating to privacy or the processing of personal information and any statutory instrument, order, rule or regulation implemented thereunder, each as applicable to Capstone in the context of its processing of personal information via websites on which this Privacy Notice is published. European Economic Area, United Kingdom, and Cayman Islands natural persons should refer to our section on your rights under the GDPR and DPA below. Notice at Collection: Personal Information We Collect

Depending on how you interact with us, we may collect the following categories of personal information:

- **Personal identifiers:** name, email address, your home or billing address, telephone numbers, customer number, user alias, information related to customer reviews, mobile advertising ID.
- Internet or other electronic activity information: your device and browser type, IP address, your browsing and search history on our website, and information regarding your interaction with our website and our advertisements.
- Inferences drawn from personal information we collect.

We have collected the same categories of personal information in the 12 months prior to the date of this Privacy Notice.

Notice at Collection: Purposes for Collection of Personal Information

We process your personal information to monitor or improve our website; to customize your experience; to deliver advertisements and marketing promotions and offers about products we think may be of interest to you, to respond to your enquiries, and to analyze the placement and effectiveness of our advertisements and other marketing efforts; for customer support; for internal business analysis; to prevent fraud, activities that violate our contracts, or that are illegal; and to protect our rights and the rights and safety of our users or others.

And we may disclose or transfer your personal information to a third party in the event of an actual or potential sale, merger, reorganization of our entity or other restructuring.

Personal Information of Minors

Securing Your Personal information

We implement and maintain reasonable security appropriate to the nature of the personal information that we collect, use, retain, transfer or otherwise process. However, there is no perfect security, and reasonable security is a process that involves risk management rather than risk elimination. While we are committed to maintaining a reasonable information security program, no such program can be perfect; in other words, all risk cannot reasonably be eliminated. Data security incidents and breaches can occur due to factors that cannot reasonably be prevented. Accordingly, it cannot be assumed that the occurrence of any given incident or breach results from our failure to implement and maintain reasonable security.

U.S. State Data Privacy Rights

Consumer Rights Under Comprehensive U.S. State Data Privacy Laws

State privacy laws in certain states give state residents various rights with respect to many types of personal information we collect about them, with some exceptions. We list below the rights that may be applicable to our business under these laws, noting that such rights are only applicable for certain state's residents.

<u>Right to Know</u>: The right to confirm whether or not we are processing a resident's personal information and to access such data. Laws in some states provide the right to know more detailed information. Specifically, California's privacy law gives residents the right to request the following additional information collected since January 1, 2022: Categories of personal information we have collected about them; categories of sources from

which such personal information was collected; categories of personal information that the business sold or disclosed for a business purpose about the consumer; categories of third parties to whom the personal information was sold or disclosed for a business purpose; and the business or commercial purpose for collecting or selling your personal information.

<u>Right to Access / Copy</u>: The right to access or request a copy of the personal information we have collected from the resident, subject to certain exceptions.

<u>Right to Delete:</u> The right to request deletion of their personal information that we have collected from or about the resident and to have such information deleted, subject to certain exceptions.

<u>Right to Correct:</u> The right to request that we correct inaccuracies in the resident's personal information, taking into account the nature of personal information and purposes of processing such information.

Right to Limit the Use of Sensitive Personal Information: California's law gives residents the right to request that we not use or disclose their sensitive personal information for inferring characteristics about a consumer or for purposes other than to provide goods and services, protect and investigate fraud and other security-related issues, non-personalized advertising, and similar purposes described in the law. Currently, we are not using your sensitive personal information for purposes that would require that we provide you with a right to limit.

California Shine the Light

California Civil Code Section 1798.83, also known as the "Shine the Light" law, permits California residents who have an established business relationship with us to annually request information about the personal information disclosed to third parties for their direct marketing purposes in the preceding calendar year. We do not and did not make such disclosures.

Exercising Your Rights

We will respond to requests from residents of states with data privacy laws that apply to us and will do so with respect to the rights that are provided under the requestor's state law as of the effective date of that law. If we require additional information or time to process your requests, we will contact you.

Exercising Your Rights Using Authorized Agents

If you would like an authorized agent to submit a CCPA request on your behalf or if you are an authorized agent of a consumer and registered with the Secretary of State to conduct business in California, please send us an email at clientservice@capstoneco.com for instructions and details on proof required for use of an authorized agent, including a copy of the written permission signed by the consumer for the agent to act on the consumer's behalf in this manner. We may deny requests from authorized agents who do not submit proof that they have been authorized by you to act on your behalf. We may also require that you directly verify your own identity with us and directly confirm with us that you provided the authorized agent permission to submit the request.

Verification of Requests

The verifiable Consumer Rights Request must provide sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative. Please describe your request with sufficient detail for us to properly understand, evaluate and respond to it. When you submit a Consumer Rights Request, we may also ask that you provide clarifying or identifying information to verify your request. Such information may include, at a minimum, depending on the sensitivity of the information you are requesting and the type of request you are making, your name and email address. Any information gathered as part of the verification process will be used for verification purposes only.

If we are unable to verify your identity with the degree of certainty required, we will not be able to respond to the request. We will notify you to explain the basis of the denial.

When We Do Not Act on a Request - Appeal Process

In some cases, we may not act on your requests (e.g., if we cannot do so under other laws that apply). When this is the case, we will explain our reasons for not providing you with the information or taking the action (e.g., correcting data) you requested.

Additionally, you have the right to appeal our decision by contacting us at same method used to submit requests within 30 days after your receipt of our decision.

Non-Discrimination

If you exercise any of the rights explained in this Privacy Policy, we will continue to treat you fairly. If you exercise your rights under this Privacy Policy, you will not be denied or charged different prices or rates for goods or services or provided a different level or quality of goods or services than others.

Right to Object - Please note that customers in the EU/UK have a right to object to the processing of their personal information where that processing is carried out for our legitimate interests. Please note however that we may not be able to fulfil this request in all instances.

Consequences of not Providing Personal information

Where we require your personal information, failure to provide this information means we may not be able to provide our services to you.

International transfers

For the operation of our website, personal information may be transferred to countries outside the EEA, UK, or the Cayman Islands ("Third Countries"), such as to jurisdictions where we conduct business or have a service provider, including countries that may not have the same level of data protection as that afforded by the Data Protection Law in the EEA, UK, or the Cayman Islands, for example the U.S. In such cases, we will process personal information (or procure that it be processed) in the Third Countries in accordance with the requirements of the Data Protection Law, which may include having appropriate contractual undertakings in legal agreements with service providers who process personal information on our behalf in such Third Countries. You may obtain further information and a copy of the appropriate or suitable international transfer safeguards that we have in place by contacting us as described below (see "Who to contact about this Privacy Notice").

Your rights under Data Protection Law

You have certain rights under the applicable Data Protection Law in relation to our processing of their personal information and these are, generally: (i) the right to request access to your personal information; (ii) the right to request rectification of your personal information; (iii) the right to request erasure of your personal information (the "right to be forgotten"); (iv) the right to restrict our processing or use of personal information; (v) the right to object to our processing or use where we have considered this to be necessary for our legitimate interests; (vi) where relevant, the right to request the portability; and (vii) where your consent to processing has been obtained, the right to withdraw your consent at any time.
